Generators

1,000 MW and above	\$49,900
500 MW to 999 MW	\$35,000
200 MW to 499 MW	\$30,000
80 MW to 199 MW	\$26,600
30 MW to 79 MW	\$20,500
3 MW to 29 MW	\$578 per MW
2 MW and below	\$750 flat fee

Developers

Projects under development pay 50 percent of the final project MW fee until financial closing at which time the regular generator rates become effective

Power Marketers

All power marketers pay a flat dues rate of \$7,500

Financial Institutions

Banks, investment houses and other financial institutions pay a flat dues rate of \$5,000

Suppliers

All other companies engaged in the business of providing goods and services to the wholesale electric industry pay a flat dues rate of \$3,500
